

## Lithofin Limescale-Away

### Description

Lithofin Limescale-Away is a highly effective, concentrated acidic cleaner. The product is nearly odourless, does not generate any vapours and can be completely rinsed away with water.

### Properties

Lithofin Limescale-Away removes limescale, water spots, calcium and similar stubborn deposits quickly and effectively

### Field of Use

For quickly and effortlessly removing encrustations and deposits from ceramics and porcelain tiles, sanitary fittings, water taps, kettles, coffee makers and other hot water equipment and household appliances.

### Directions for Use

#### Fixtures and surfaces in kitchen and bath:

Apply with a cloth or sponge, allow to work then rinse with clear water.

#### Shower heads:

Mix ½ cup of Lithofin Limescale-Away with 2 cups of water, submerge shower head in solution, allow to work, then rinse well with clear water.

#### Coffee machines:

Fill with ½ cup of Lithofin Limescale-Away and 2 cups of water. Switch on and run 1 cup through the machine, then switch off. After 15 min. switch machine on again and run the rest through, then rinse 2 to 3 times with clear water.

Please Note: do not use on surfaces sensitive to acid such as marble, limestone, aluminium, enamel, bronze, some decorative tiles and plastics, wood and textiles, etc. Always try the product in an inconspicuous area prior to use.

Coverage: 5 to 10 uses per bottle

### Storage

Keep closed, cool and dry.  
 Shelf life of up to 4 years.

### Environmental Protection

Surfactants are biologically degradable in accordance with EU-regulations.

Disposal: diluted product may be added to waste water. Containers are made of environmentally friendly polyethylene (PE). Clean containers can be recycled through collection systems.

### Safety

Ingredients: acids, <5% non-ionic surfactants, auxiliary agents.
