

Lithofin Sticker Remover

Description

A special LITHOFIN-Product for removing all kinds of stickers and labels and for effectively removing adhesive residues from almost any surface.

Properties

Lithofin Sticker Remover quickly and effortlessly removes adhesives and facilitates removing stickers and stubborn residues.

Field of Use

For removing stickers, labels, adhesive tapes and residues. Also removes splashes of rubber, tar, fresh paint, etc. Suitable for nearly all surfaces made from stone, ceramics, glass, etc.

Directions for Use

First peel of the sticker as far as possible, then put some Lithofin Sticker remover on a cloth and thoroughly wet the adhesive residues. Allow the product to work for a few minutes, but do not allow it to dry.

Rub the residues off the surface with a dry cloth.

In case of stubborn residues, you may have to repeat this procedure.

Please Note: on sensitive surfaces such as lacquer, paint, etc. try the product in an inconspicuous area prior to use.

Storage

Closed, cool and dry. Not above 25°C. Up to 5 years .

Environmental Protection

Free of chlorinated hydrocarbons.

Disposal: liquid product is classified as special waste.

Containers are made of environmentally friendly tinplate. Clean containers can be recycled through collection system.

Safety

Ingredients: <30% aliphatic hydrocarbons, 15-30% aromatic hydrocarbons, <5% non-ionic surfactants, auxiliary agents.

Labelling according to EU-Directive 1272/2008(CLP):

Symbol GHS 02, 07, 08, 09 Danger

Hydrocarbons, C9-C12, n-alkanes, isoalkanes, cyclics, aromatics, benzene.
