

Lithofin MN Care-Sheen

Description

A special product from the LITHOFIN range for marble, natural stone and cast stone (MN). Solvent-free wax milk based on natural Waxes with high-quality polymer additives and cleaning-supporting and self-shining additives.

Features

Lithofin MN Care-Sheen gives stone surfaces a fresh, shiny appearance, while at the same time refreshing the colour. The surface becomes less sensitive and visually more beautiful.

Technical data:

Scope of application

For occasional gloss refreshment of polished or matt marble and granite floors.

For the initial care of rough (e.g. slate, Solnhofener) sanded or matt pavements of all kinds as well as in the formation of a running street. For more shine, polish the surface – preferably by machine.

Lithofin MN Care-Sheen also has a cleansing effect and can be used as a mop for floors with low wear and tear (e.g. bathrooms).

Only suitable for indoor use.

Processing

For the initial care of matt coverings, Lithofin MN Care-Sheen can be applied pure or diluted up to 1:1 with water with a clean cloth, sponge or lambskin mop. After a drying time of approx. 30 to 40 minutes, the topping can be additionally polished by machine or by hand. To refresh or maintain the shine, wiping the topping is sufficient (1 cup of Lithofin MN Care-Sheen per 10 litres of water). For areas that have already been ced, add a little more.

Do not walk on the topping during the drying time.

Drying time: approx. 30 to 40 minutes

Yield:

approx. 200 m²/litre when applied in wiper water,
approx. 20 m²/litre when used undiluted.

Storage

Closed and cool, but frost-free.
Can be stored for up to approx. 3 years.

Recommendation

Natural stone floors should be mopped with a damp cloth regularly. The following care method is particularly effective for polished marble:
For wiping, use Lithofin MN Wash & Clean 3 to 4 times and then 1 time Lithofin MN Care-Sheen.

Environmental protection

The surfactants are biodegradable in accordance with Regulation (EC) No. 648/2004 (detergents regulation).
Disposal: The container is made of environmentally friendly polyethylene (PE) and is recyclable. Rinsed containers can be disposed of and recycled via the recyclable material collection system (see note on label).

Packaging

- a) 1 litre bottle with child-proof cap (10 per box)
- b) 5 litre canister (2 per box)
