

Lithofin P&L Basic Cleaner for Parquet and Laminate

Description

A special product from the LITHOFIN-Range for parquet, laminate, linoleum and other synthetic floors (P&L). This mildly alkaline special cleaner contains a balanced combination of components which dissolve and remove dirt.

Properties

Lithofin P&L Basic Cleaner is specially formulated to remove engrained dirt, glossy films and care product residues.

Field of Use

For initial cleaning of newly laid parquet and laminate and for thoroughly cleaning used and dirty surfaces. Lithofin P&L Basic cleaner completely removes encrusted care product residues and films.

Directions for Use

Dilute Lithofin P&L Basic Cleaner up to 1:2, apply and distribute with a mop and allow the product to work for five minutes. The effectiveness can be enhanced by scrubbing. Wipe the surface with a damp mop to remove the product. Do not allow water to remain on the surface, since this may cause the wood to swell at the joints. In case of extremely dirty surfaces, the product can be used undiluted. This process may have to be repeated.

Please Note: parquet and laminate floors may absorb water along the joints and swell up. Therefore working time must be kept to a minimum and the floor should not remain wet for extended periods of time.

Please observe the cleaning and maintenance advice provided by the manufacturer of the floor material.

Coverage: approx. 20 to 30m² per litre (depending on dilution).

Storage

Closed, cool and dry. Up to 5 years.

Environmental Protection

Does not contain any phosphates. The contained surfactants are biodegradable according to regulation (EC) No. 648/2004 (detergents regulation).

Disposal: waste code according to EWC/AVV 07 06 08*. Bottles/canisters are made of environmentally friendly polyethylene and can be recycled (see information on label).

Ingredients: < 5% non-ionic surfactants, benzisothiazolinone, limonene, citral, geraniol, sodium pyrrithione, auxilliary agents.
