Directions for Use

Add a small amount (approx. 10 ml) per 5 litres of warm water. After wiping, allow the residues to dry on the surface, do not rinse with clear water. Use either a floor mop, cloth or cleaning machine for wiping. For highly polished dark floors, a dry buffing with a soft cloth will keep them shiny.

<u>Coverage:</u> Green by Lithofin Daily Care Cleaner is a high-yielding concentrate and very economical.

Storage

Closed, upright, cool, up to 3 years.
